There are non-market factors in some areas, and fair competition has not been realized, especially for some small enterprises, whose living environment is not very ideal.

2.2 The competitiveness of enterprises is not strong

Although private enterprises in Anhui Province have developed rapidly in terms of quantity and industry respectively, many of them are not very competitive, their independent innovation ability is poor, their innovation efforts in product and service are insufficient, and the tendency of assimilation is obvious. Some enterprises have low technical level, lack of industrial workers and poor production capacity. Moreover, many enterprises have insufficient industrial chain extension. 2.3 Enterprises have financing difficulties

In this way, private enterprises can only deal with bank acceptance bills at discount interest, which will increase their financial costs. Private enterprises have difficulties in financing and high financing costs. This is an objective existence, which restricts the development of private enterprises to a large extent, and it is difficult for private enterprises to effectively feel the benefits of tax and fee reduction policies.

2.4 The problem of high taxes and fees still exists

According to the survey, our overall tax ratio is still on the high side compared with other countries. Our overall tax ratio even exceeds that of some countries with high social welfare. In addition, according to the survey, the contribution of private economy in Anhui Province is still quite high tax ratio, more than the overall proportion of the national team, which shows that the private economy in Anhui Province in tax sharing is quite high, but from the perspective of you, Anhui Province will be hard to your tax burden is still high. In the context of tax reduction and fee reduction, Anhui Province has introduced some relevant distribution policies. Due to insufficient publicity, the implementation of some policies is not very optimistic, and many private enterprises have not been able to enjoy the dividends of tax reduction and fee reduction policies in time.

Based on this, the industrial process is optimized, the safety incidents in the industrial production process are reduced, the national production safety requirements are met, and the level of industrial production is improved.

Dendrobium officinale (*Dendrobium officinale* Kimura et Migo) is a kind of rare Chinese herbal medicine, which has the effects of nourishing Yin and clearing heat, stimulating stomach and producing fluid, anticancer and immune regulation [1].

The earliest records about dendrobium can be traced back to the Eastern Han Dynasty "Shennong Ben Cao Jing": "Dendrobium, taste sweet, the main injury, eliminate Bi Qi, fill the five zang deficiency to win thin, strong Yin. Long take thick stomach, light body and p rolong one's life, a Lin LAN "[2]. Dendrobium has been listed as top medicinal herbs.

"Rihuazi Materia Medica" in the period of Five Dynasties and Ten Kingdoms: "cure deficiency, weaken labor, strengthen muscles and bones, warm water and dirty water, improve intelligence, calm stomach, and chase deficiency and evil" [3]. Dendrobium officinale can treat weakness caused by deficiency and fatigue, strengthen tendons and bones, nourish kidneys, enhance intelligence, and restore the weak gastrointestinal function to normal, so as to achieve the ACADEMIC PUBLISHING HOUSE

purpose of filling deficiency.

Tao Hongjing, a medical scientist in the Southern Dynasty, wrote in his book'Records of Famous Doctor': "Enrich essence, fill the deficiency of inner medicine, smooth stomach, lengthen muscles, drive away evil heat from skin, pain and weakness in feet and knees, strengthen Yang, tonify kidney and accumulate essence" [4].

The Theory of Medicinal Properties by Zhen Quan at the end of Sui and the beginning of Tang Dynasty: "It can benefit qi and remove heat, treat men with weak waist and feet, strengthen Yang, tonify kidney and collect essence" [5].

In Tang Dynasty, the medicinal status of dendrobium was further established, and the classic Taoist work 'Daozang' named Dendrobium as "the first of the nine immortal herbs of China" [6].

In the late Ming Dynasty, Li Shizhen's Compendium of Materia Medica recorded its main treatment: "In the middle of injury, it eliminates the qi under Bi, replenises the five zang organs and loses weight due to deficiency, strengthens Yin and improves essence. Long term use, thick stomach. Fill inside must be insufficient, flat stomach gas, long muscle, skin evil heat rash gas, knee pain cold Bi weak, treating Qi-Blood, the treatment of men's waist and feet weak, healthy Yang, skin muscle wind bi, bone in the long cold, tonifying kidney. Strengthen muscles and bones, warm water dirty, puzzle clear gas. Treat fever and perspiration, and discharge abscess [7].

In the Anthology of Compendium of Materia Medica written by Zhao Xuemin, a famous doctor in the Qing Dynasty, "It clears the stomach and removes deficiency heat, produces fluid, and causes fatigue. It replaces tea with tea, appetizes the appetite and strengthens the spleen, calms the breath and cures the wind, reduces phlegm, relizes heat, and reduces Qi-Blood. It is called the treasure of nourishing Yin and nourishing the body" [8].

3. CONSIDERATION OF FUNCTIONS AND QUANTITATIVE INDICATORS OF DENDROBIUM OFFICINALE IN MODERN TIMES

After years of practice, it has been realized that

Dendrobium officinale contains a variety of chemical components, mainly including polysaccharides, astragalus membranaceus, flavonoids, alkaloids, amino acids, volatile substances, amino acids and trace elements, which are the material basis for Dendrobium officinale to exert pharmacological activities [9].

Pharmacopoeia of the People's Republic of China (2015 edition) confirmed that the detection and identification indexes of Dendrobium officinale included mannose and glucose peak area, water content, total ash and extract, while polysaccharide was not the characteristic of Dendrobium officinale component content. Other compounds were gradually discovered. In 2009, Li Yan [10] isolated Astragalus and its derivatives from Dendrobium officinale. the flavonoid aglycones identified in Dendrobium officinalis include apigenin, naringin, sacronol, chrysoflavin, quercetin, taxophyll, isorhamnetin and 3', 5', 7-tetrahydroxy dihydroflavone, mainly flavonoids, flavonols, dihydroflavonoids and other flavonoids [11]. Dendrobium officinale contains 17 amino acids, including 7 essential amino acids for human body, and the amino acid content will increase with the increase of physiological age [12]. Dendrobium officinale contains 11 metal elements including potassium, calcium, manganese, zinc, copper, magnesium, mercury, chromium, lead, arsenic and cadmium [13]. In the stem, the mass fraction of iron (71.10 mg/kg) and selenium (1.07 mg/kg) is high, which has high nutritional value [14].

4. HIGH QUALITY CHARACTERISTICS AND FORMING FACTORS OF IMITATION WILD ECOLOGICAL CULTIVATION

According to the growth habit of wild Dendrobium officinale, wild ecological cultivation can be used in the natural environment under the forest, and two cultivation modes of living tree epiphytic cultivation and epiphytic epiphytic original cultivation have been initially formed, which can effectively improve its quality.

Based on UPLC-MS /MS detection platform, the flavonoids and alkaloids in the simulated wild culture Dendrobium officinale were significantly different among groups in principal component analysis, among which the flavonoids were the largest, up to 129 species. There are 39 kinds of alkaloid components. the quality of wild Dendrobium officinale increased with the extension of time. Generally, the new strips cultivated with stone for 2 years and with tree for 3 years could achieve the quality of wild dendrobium officinale.

5. CONCLUSION

The root microbial diversity of wild Dendrobium officinale is rich, and the diversity of rhizosphere microbial species and the population number of dominant flora directly affect the quality of wild dendrobium officinale. the high quality of the stone planting model may be related to the abundant mineral

nutrients in the environment. the amount of mineral nutrients in the trunk runoff of the tree planting model also determines its biomass and quality. the organic nutrients supplied by the environment is closely related to the microbial activities in the environment. Therefore, the cultivation environment with high temperature and high humidity conducive to microbial growth is an ideal place to cultivate high-quality Dendrobium officinale in ecological cultivation. the characteristics of imitational wild cultivation of Dendrobium officinale can reach the natural wild quality, which reflects its biological drug efficacy and leads the direction of industrial cultivation of Dendrobium officinale.

In general, the students with high empathy tend to have strong quality, can stand on the point of view of others, considering the low empathy ability of students, on the other hand, less likely to stand on the point of view of others, so training scheme in combination with the actual situation of students, so as to have targeted training effect.

3.4 Having the ability to handle emergency situations The communication process may be affected by many factors, such as cultural and regional differences. In view of these emergency situations, students need to be equipped with the ability to deal with emergency events, learn to break the awkward situation, ensure that the communication process is normal and will not be affected by various factors, so as to better cope with emergency situations [2].

4. STRATEGIES TO CULTIVATE STUDENTS' INTERCULTURAL COMMUNICATIVE COMPETENCE IN JAPANESE MAJOR TEACHING IN COLLEGES AND UNIVERSITIES

At present, it is of great significance to cultivate students' intercultural communication ability, especially in the teaching of minor languages. Therefore, colleges and universities should pay more attention to the reform of Japanese teaching, innovate teaching models and teaching methods, and encourage students to master more communication skills, so as to lay a solid foundation for future development.

Thirdly, colleges universities should establish cooperative relations with excellent local enterprises, so that students can enjoy practical opportunities and know the proprietary knowledge in the field of Japanese culture in enterprises, which will help broaden their knowledge horizon and achieve the goal of improving students' practical ability [3].

4.3 Building a teaching staff

Teachers are the instructors in the teaching of Japanese. students' intercultural to improve communication ability, colleges and universities should set up a team of high-quality teachers to encourage students to enhance their communicative awareness and learn more communicative skills and knowledge points, so as to improve students' intercultural communication ability. And, should pay attention to investment in teachers colleges and universities, offer learning opportunities for teachers, let teachers can take the initiative to learn new knowledge, access to more advanced teaching ideas and methods, and then guide for students, encourage students to enrich their learning experience, gain more new culture, and stimulate the learning interest in Japanese culture. From the perspective of schools, more attention should be paid to the training of teachers. By organizing teachers to study and participate in lectures on a regular basis, teachers can also have the ability of intercultural communication. Only in this way can the teaching level of Japanese major in colleges and universities be guaranteed and the learning effect of students can be strengthened.

5. CONCLUSION

At present, our country and Japan have more and more close communication, in order to realize unimpeded communication, we should pay attention to the training of talents majoring in Japanese, promote more students to have cross-cultural communication ability, so as to meet the needs of the development of the current times. From the point of the actual teaching situation, many colleges and universities not to strengthen the reform of teaching mode, to strengthen the students' learning experience, to take timely innovation strategy, provide more practice opportunities for students, and to enrich the content of classroom teaching, such as customs, traditional festival in Japan into the teaching activity, this is beneficial to stimulate students' learning enthusiasm, So that students can actively participate in communication activities, and then improve their intercultural communication ability.

More than 20 colleges and universities in Shaanxi have launched cooperative education programs with 11 countries and regions including Russia, the UK, the US, Australia and so forth, covering disciplines including engineering, literature, economy and so on. There are more than 10, 000 university students enrolled, and the number of programs and institutions and the scale of education all rank first in Northwest China.

3. THE IMPORTANCE OF IDEOLOGICAL SECURITY EDUCATION FOR COLLEGE STUDENTS UNDER CHINESE-FOREIGN COOPERATIVE EDUCATION

Adult education needs to use modern technology to update the education platform. Finally, in the context of big data, the medium and long-term goal of the development of education in our country is to create a sound lifelong education system, which is also the needs of the development of social subjects, can increase the economic interests of our country. the emergence of lifelong education concept can serve as a condition for the further advancement of adult education, and will promote the personalized learning of adult education students as the goal to enrich the education model, so that adult education will be full of new vitality and vitality.

2.2 It can promote the development of adult education. At present, the main participation of Chinese adult education is labor and on-the-job staff. the traditional adult education in the process of development, although it has achieved certain results, but there are many problems, which have hindered the development of the adult education industry. Adult education students have big gaps in education level, age and family conditions, etc. If centralized teaching is conducted, it is difficult to reasonably coordinate and meet the development needs of all students, and self-study is not reliable guidance, so the current model of adult education can

hardly meet the engineering needs of students [2].

3. PROBLEMS IN THE INTEGRATION OF DISTANCE EDUCATION AND ADULT EDUCATION UNDER THE BACKGROUND OF BIG DATA

3.1 There is a certain lag in the concept of education Correspondence education is the key mode of traditional adult education. Correspondence education in our country first appeared in the middle of last century. Generally, correspondence textbooks are given to students. After the students have been self-taught for some time, they focus on the faceto-face teaching work and test the teaching results through examinations. objectives the correspondence teaching and distance education are the same, and they both hope to reasonably coordinate the adult learning time, which belongs to the part-time teaching mode. However, there is a big gap between correspondence education and distance education in the way of enrollment and management. Correspondence teaching is based on adult entrance examination, while distance education is conducted independently by the host colleges and universities, which can make enrollment more flexible and open. In the course of correspondence teaching, paper carrier is used as the main medium, while the distance teaching is made more interesting by means of electronic teaching materials which can integrate picture, text, sound and video. In the management of correspondence education, it is necessary to set up special local correspondence teaching sites and teachers to carry out offline teaching. However, the standards of correspondence teaching stations in different places are not consistent, and the overall strength of teachers varies. the self-teaching and self-examination of correspondence teaching stations reduce the quality of adult education to some extent. Students are required to have strong autonomy [3]. With the implementation of higher education self-study examination policy and the improvement of network education quality, if adult education still uses correspondence teaching mode, there will be many problems. However, due to the differences in learning resources, evaluation standards and management modes between correspondence teaching and distance education, most adult colleges and universities find it difficult to integrate the two education modes and lag behind in educational concepts, which seriously hinders the development of relevant work.

3.2 Failure to update information technology in time The integration of adult education and distance education requires the premise of information infrastructure and information technology. At present, there are many problems in the integration of adult education and distance education. First, when carrying out adult education, it is likely that the available funds will be insufficient, resulting in a certain lag in the construction of network infrastructure. Some small-

scale adult colleges and universities are unable to build a special network system, and those with sufficient capacity do not pay attention to software and hardware update, broadband expansion and other work, which may hinder the upload and application of online teaching materials. Second, the information literacy of adult education staff will have a direct impact on the selection and construction of distance education resources. Under the background of big data, there are more education resources. Teachers are required to analyze the huge and diverse education resources and find out the distance education resources with strong compatibility that can meet the teaching syllabus of adult education. In addition, in the process of online registration and online course selection, advanced teaching resources are not converted into network resources in time, which leads to a certain lag in the teaching. Third, the self-developed distance education resources cannot be integrated, and it is difficult to achieve the goal of resource sharing. Normally, colleges and universities responsible for adult education will independently develop distance education resources, while the correspondence teaching site does not have a platform capable of summarizing teaching resources, so it is difficult to efficiently apply a variety of different resources [4].

3.3 The management mode used is fixed

First, adult education under the traditional model still adheres to the correspondence model, and the standards of enrollment time, teaching materials and learning progress are consistent. This centralized management mode is difficult to meet the needs of the diversified development of adult education students in the new era. From a certain point of view, it hinders the openness of the distance education system. Especially in the enrollment management and assessment management, correspondence education will use the measure of national unified examination, while distance education is the self-examination model of wide admission and strict exit. Correspondence education uses a single assessment as an indicator, and the standards are set by the correspondence site. Distance education students need to take the examination in several different stages, the evaluation standards and certification mechanism used by the two are quite different. If adult education cannot update the existing management mode, it is difficult to make the two compatible. In addition, under the traditional mode, adult education, file registration, score management and other work are all in charge of the correspondence station, which increases the work pressure of teachers to a certain extent. Distance education allows students to register online and choose the courses they need to learn, and the grades are automatically generated. the management efficiency is significantly higher than that of correspondence teaching.

4. MEASURES TO INTEGRATE DISTANCE

EDUCATION AND ADULT EDUCATION

4.1 Update the concept of adult education

In the new era, adult education participants have a new demand for the sense of learning experience, which needs to adhere to the people-oriented in adult education, clear the connection between traditional education and distance education, find a balance point, to prevent the occurrence of serious consumption of adult education. First, we should update the concept of substitution theory. the educational objectives of correspondence education and distance education are the same. To strengthen the connection between adult education and distance education does not mean to cancel a certain party. It is necessary to take inheritance as the premise of reasonable innovation. Second, we need to recognize our respective strengths and weaknesses. When adult education has developed into the modern age, it has certain advantages, such as centralized face-to-face teaching, which can help students solve the problems existing in the learning process through face-to-face teaching and provide opportunities for students to practice, which is beyond the reach of distance education. Distance education is rich in teaching resources, which will not be affected by time and place, and its advantages such as relatively low cost are beyond the reach of distance education. Finally, under the guidance of the network concept of correspondence education, a variety of different teaching resources should be reasonably applied to enrich correspondence education with the help of distance education, so as to ensure that the educational concepts, resources and integrated management of the two can be connected to meet the actual learning needs of education subjects.

4.2 Rational integration of educational resources

If we want to strengthen the connection between traditional correspondence education and distance education, and show the maximum function of distance education resources, we must strengthen construction of information platform. First, the existing network infrastructure should be improved. At present, the available teaching resources of adult education are relatively few, and it is difficult to meet the needs of the masses by building an independent network system. There has to be cooperation. Regions can be taken as units, and with the support of local governments, cooperation between Internet providers and universities can be strengthened to build a special adult education information platform. In this process, it is also necessary to regularly upgrade and update the campus network platform to avoid the high working pressure of the network platform and ensure the continuous application of online education resources in a stable state [5]. Second, the network education resources should be summarized. the construction of adult education network platform not only needs to summarize the courseware and other resources used in

correspondence teaching, but also needs to flexibly use a variety of different teaching resources to ensure that correspondence teaching can be coordinated with distance teaching resources. In this process, more efforts should be made to build a perfect network training base. Both correspondence teaching and distance education need to be supported by practical teaching. However, due to the small number of available resources, it could not be expanded. With the help of 3D imaging technology and virtual reality technology to simulate the practical environment, simulation teaching can be carried out to provide more opportunities for students to practice. Moreover, the construction of network training base can control the cost of practical training within a certain range. Third, to achieve the goal of network resource sharing. the construction of adult education network platform needs systematic and long-term development, which is difficult for adult education with weak teachers. the distance education which takes network resources as the premise also needs the support of network education platform. Therefore, achieving the goal of sharing network resources is an important measure to promote the integration of adult education and distance education.

4.3 Innovate the management model of adult education If we want to integrate distance education with adult education, we must have a perfect system as support. Under the fierce market competition, the financial operation cost is increasing, which will further lead to the increase of management difficulty. After the transformation, the enterprise's financial management is more standardized and reasonable, which can significantly improve the enterprise's risk prevention and control ability, improve economic benefits, and

enhance its core competitiveness. At the same time, financial data can provide a strong reference for business decisions, and financial personnel can also timely adjust financial strategies according to the current financial management problems, and optimize them, so that managers can deal with different financial data more efficiently. In the context of the current economic change, enterprises should timely adjust the financial management objectives, clear their own strategic development planning, so as to adapt to the constant changes in the economic environment at home and abroad.

2.3 THE INTERNAL REQUIREMENT OF ENTERPRISE DEVELOPMENT

3. PROBLEMS IN THE PROCESS OF DIGITAL TRANSFORMATION OF ENTERPRISE FINANCIAL MANAGEMENT

3.1 FINANCIAL MANAGEMENT SYSTEM IS NOT PERFECT

Under the traditional financial management mode, the accounting is not rigorous, the financial audit is not standard, and has not been established to adapt to it. Internal control management system, enterprise financial management system is not perfect, no internal control system in the majority of small and mediumsized enterprises or not comprehensive, not covered all the departments and link, not infiltrate into all areas of business and various operational link, do not account, money in charge of the principle, management of small and medium-sized enterprise monetary fund and the related books to chaos. There is no comprehensive regulation of financial work from the system, and the work responsibilities cannot be distributed in detail, which greatly affects the development process of financial digital transformation.

3.2 THE BUSINESS LEVEL OF FINANCIAL PERSONNEL IS UNEVEN

The core power of enterprise financial transformation is talent, the overall business level and work skill level of enterprise financial personnel are uneven. Under the current management system, enterprise's financial

management still focus on the work of financial accounting and supervision, and ignores the service for the enterprise internal management, a large number of financial personnel from the bondage of traditional financial management concept, make the accounting information as main content, attaching too much importance to reflect afterwards, and lack of prior to budget, control and decision making. In addition, they do not have the ability of digital application and can not use information technology to solve the related problems in financial work. Moreover, due to busy affairs, lack of training, management ability, work level can not be improved, innovation consciousness is also extremely lack, can not meet the requirements of sustainable development of enterprise financial management.

3.3 POOR DATA GOVERNANCE

In order to realize the financial digital transformation, it is necessary to introduce advanced equipment and facilities, and strengthen the research and application of big data technology. Due to aging equipment, different network transmission, backward technology and other reasons, digitalization has not been effectively developed and utilized in some enterprises. Department has its own data resources lack of unified and effective management, the data source is a business system provided, query, statistic data, such as lack of after data governance of multidimensional, multiple factors and multiple stage of comprehensive data, data of actual utility ratio is low, departments of unrealized application decision support based on big data. the overall service level and service quality need to be improved urgently, which is not conducive to the digital transformation of financial management. 4. STRATEGIES FOR THE DIGITAL TRANSFORMATION OF ENTERPRISE FINANCIAL MANAGEMENT

4.1 IMPROVE THE FINANCIAL MANAGEMENT SYSTEM

The enterprise should carry on the scientific planning and arrangement to the financial sharing organization structure, carries on the scientific distribution to the related work. And build a unified, complete financial information system, centralized, timely, accurate collection, integration and transfer of financial information, to ensure the smooth flow of internal funds.

First of all, establish and improve the financial management of the basic work system, promote the overall level of enterprise management. According to the operation needs of financial sharing service mode, enterprises should build a comprehensive management system, make comprehensive provisions on financial work from the system level, and determine the goal of financial digital transformation. Secondly, the establishment and improvement of self-expansion and self-restraint of the enterprise financial mechanism, to

ensure the sustainable, stable, coordinated development of enterprises to establish a sound dynamic, the whole process of financial audit supervision system. Thirdly, according to the production and operation characteristics of enterprises and the objective requirements of management, strictly implement the internal financial control and accounting supervision of enterprises.

4.2 STRENGTHEN THE TRAINING OF FINANCIAL PERSONEL

First of all, according to the operation needs of financial sharing service mode, professional training is carried out for existing financial personnel, and the enterprise financial digital transformation is carried out, and the decentralized financial methods and processes are integrated, so that the work functions are simple and specific. Enterprises need to train financial personnel in a certain professional direction to classify and clarify the previously confused functions of the financial department.

Secondly, strengthen the financial personnel professional quality education, clear financial financial personnel in work responsibilities. Accountants need to shift from traditional accounting, bookkeeping and table preparation to participating in corporate strategy. To realize the functions of financial forecasting, planning, control and responsibility assessment and evaluation, the enterprise needs to clearly define the competence and responsibility of each role of financial personnel. In addition, financial personnel need to have innovative thinking, continuous learning ability and risk and legal awareness.

4.3 ENSURING INFORMATION SHARING AND DATA SECURITY

Metcalfe's law states that the value of a network is proportional to the square of the number of users connected to it. In other words, the more resources a network integrates, the greater the value of a network. This shows that, different from the traditional closed value system based on technical barriers, digitalization is driven by open and shared value system. Only through open and shared data resources can data be

collected to the maximum extent and the value of data be maximized. However, it must be clearly recognized that the first prerequisite for open sharing is the effective guarantee of data security. Once the information data security is not effectively guaranteed, information leakage or abuse, will bring great social risks. Therefore, Digital Zibo should not only promote information sharing between Party and government organs and all kinds of subjects in the whole society, but also strengthen data security guarantee in technology, supervision, system, law and other dimensions simultaneously.

5. CONCLUSIONS

Enterprise financial management of the digital transformation is very important to the survival and development of the enterprise, is of great significance, especially more should pay attention to enterprise managers, in a timely manner to promote the enterprise financial management of the digital transformation, the transformation process should pay attention to enhance the capacity and quality of financial personnel, improve the financial management system, to ensure that the financial information and data security.

Smart City Pedestrian Traffic Modelling

Abstract: This paper proposes a comprehensive understanding of one of the most innovative trends, smart city development and this research report can serve as a basis for future building pedestrian traffic models and footpaths. the value of this research relies on providing safer and more efficient schemes for walking outdoors. This improved walkable strategy will also drive economic growth to some extent and close community bonds. To reach this goal, the aim of this paper is providing an idea to handle with complicated movement of pedestrian, such as visitors and residents, in different cities' landscapes, the main research problem is there are a limited number of relevant literature and appropriate knowledge. Therefore, this research report is based on a qualitative method based on the collection, analysing and interpretation of existing information. the literature review aim is to provide the explanation of existing IT systems which used by big cities around the world to create safe and comfortable environment pedestrians. However, it is difficult to optimize a single pedestrian traffic model for changing circumstances because every modern city has its unique public transport system, land- use program and lifestyle. Although, we can still draw on the experience of major cities in America and Australia, via collecting current data and comparing them, to list some potential influencing factors. After that this research covers the existing pedestrian monitoring technologies. Finally, I will analyse diverse influence factors in designing footpaths and street forms.

1. INTRODUCTION

With pro-active urbanization policy and growing population, the concept of "smart city" will become increasingly important in the future. Pedestrian traffic management, as one critic part of building smart city, is a sustainable development challenge. A lot of efforts have been put in researching human behaviour in a huge crowd, designing intelligent traffic lights or other devices, applying dynamically simulation platforms in metro or interchanges and demonstrating street forms and transportation networks in a specific city. Although a universal pedestrian traffic modelling based on different population density and the layout of urban functions is still rarely in practice. In this paper, I try to look into a comparison of different pedestrian strategies used in classic cities of American and Australia via data collecting and then propose an idea of a common pedestrian traffic model. This paper is organized as follows: Section 1 discussed research background, significance of research project, aims, and methodology used, research questions and expected outcomes. Section 2 briefly demonstrates related work on pedestrian traffic management and existing cases of traffic management in smart city. While Section 3 analyses diverse influence factors in designing footpaths and street forms, through comparing major cities in America and Australia, and finally shares an idea of smart city pedestrian traffic modelling. 1.1 BACKGROUND

It is predicted that by 2050 about 64% developing countries and over 80% developed countries will be urbanized (Admas, 2013). In this circulation, the concept of smart city has been raised since 2015, based on integrating information and communication technology (ICT), aimed to manage resources sustainably and efficiently (Cohen, 2015). [3] However, safer and more efficient traffic management strategies, especially designed for major cities in American was launched at the December 2015, as one of the most important smart city challenges (Bush, 2016). the core of this challenge is how to dynamically coordinate crowded pedestrian flow with limited layout of streets in a city.

1.2 SIGNIFICANCE

Anyone is hardly to avoid pedestrian journeys in everyday life. the value of this research relies on design a model to handle with complicated movement of pedestrian in different cities' landscape. [4] Therefore, people who lived in smart city could enjoy a safer and more efficient walkable experience. This not only means saving time and reducing the hidden danger of safety for individuals but also boosts the economic development for shops close to streets and increases community connections.

1.3 RESEARCH FOCUS

1.3.1 RESEARCH PROBLEM

Every modern city has its unique public transport system and land-use program. However, when we modelling pedestrian movement behaviour and designing town planning, diverse factors need to be take into account, such as mobility need, land use accessibility and budgets. Thus, it is difficult to optimize a single pedestrian traffic model for changing circumstances.

1.3.2 RESEARCH AIM

The goal of this paper is to consider existing pedestrian monitoring technologies and to analyse diverse influence factors in designing footpaths and street forms, through comparing typical cities in America and Australia.

1.3.3 RESEARCH QUESTIONS

What approaches can be used to improve pedestrian traffic management?

What situations should be taken into consideration regarding dynamic flow of people?

How to design a sustainable, walkable, liveable street forms and networks?

2. LITERATURE REVIEW

The aim of this chapter is to provide the relevant information to serve as the theoretical basis for this research report.

Existing Pedestrian Monitoring Technologies Historically, most of the work on the measurement of traffic in cities related to cars (Huyi, 2016). Cities have

been optimized for cars. Naturally, with a change in the approach to development, questions arose to research of all traffic. This research report concentrates on methods of collecting information on pedestrian traffic. Before we can analyse and identify patterns of behaviour, we need to learn to collect the source information. There are many existing technologies to count and monitor non-motorized traffic (Pedestrians and bicycles). By reviewing the existing counting and monitoring technologies, the 9 technologies were identified which can be used specifically for pedestrians counting (Steinmetz, 2017). [5]

Factors influencing pedestrian flow volume and traffic To design a sustainable and walkable street forms and networks, there is a need to understand factors that have influence for travel patterns:

Time and weather effect:

Pedestrian volumes are significantly affected by the time of the day (for example, in Sydney, 7am to 9am and 5pm to 7pm are peaks).

Weather conditions also significantly influence pedestrian activities (for example temperature and precipitation). Based on Niemeirt (2012) research report, temperature has more effect for pedestrian volume rather than the amount of precipitation

(Niemeirt, 2012). [6]

Socio-economic factors:

In this factor, gender, age, education can be considered. Based on Gerrard's research in 2013, men cycle is more than women, but less than student cycle (Gerrard, 2017). Social factors characterize the influence of the level of social stability in society, the existing social structure, social security of the population, and the development of the vocational education system.

Trip related factors:

Purpose of the trip or trip distance are the significant factors that can have influence on individual's mode choice decision.

Infrastructural Factors:

In this case, the presence of sidewalks or bicycle parking facilities can be considered. It can significantly encourage or discourage the people to make a decision about using public transport (Cristiani & Peri, 2017). Smart Pedestrian Projects in Smart Cities:

Australia

1st May 2018, university of Wollongong introduced the new pedestrian project to help to reduce traffic in the Liverpool CBD (Karg, 2018). the main idea of this project is to collect data from smartphones and using the latest traffic-counting technology to track pedestrian and vehicles movement in real time in an effort to better plan cities and build infrastructure where it is most needed. Sensors will be placed in the key places around the Liverpool City Center and will be connected through a Low Power Wide Area Network or LoRaWAN (Gron, 2018).

LoRaWAN is an open protocol for high-capacity (up to 1, 000, 000 devices in one network) networks with a large range and low power consumption (Austroads, 2018).

London

A group of architects, designers and creative technologists, collectively known as Umbrellium, developed a new vision for the pedestrian crossing (Umbrellium, 2017). the Starling Crossing project aims to create "smart" pedestrian crossings that help people cross the road, drawing a zebra in real time, as well as stop lines and directions for drivers that prompt when to slow down and stop.

The prototype system was already installed temporarily in southern London (McPartland, 2017). the whole transition zone is controlled by cameras, images from which fall into the neural network, capable of recognizing pedestrians, cyclists and vehicles. the network can also determine the location and speed of each member of the traffic, which allows foreseeing their next steps. the system can be programmed so that it will only work when it sees a pedestrian, or it can increase its width to cope with large pedestrian traffic (Umbrellium, 2017).

Dubai

Smart Pedestrian Signals technology is controlled by a system based on sensors connected to a ground-based optical system synchronized with the traffic signal switching (Dum, 2018). This system allows pedestrians to cross the road safely, without interfering with the movement of vehicles. In addition, the system is able to control the traffic flow without slowing it down and resuming immediately after the pedestrian has left the carriageway. Thus, the RTA representatives responsible for the project believe that these innovative transitions not only provide safety and convenience, but also save time for all road users (kroglova, 2018).

San Diego

San Diego announced a partnership with General Electric. In the street lights of the city will build 3200 sensors that will help you find parking spaces, optimize traffic, improve safety and air quality (Runat, 2017). This initiative is part of the San Diego strategy to reduce the number of road accidents and other emergencies. With the help of urban sensors built into the lights, you can quickly respond to incidents. In addition to the installation of intelligent sensors, the project will update approximately 25% of street lights. the city will install 14 thousand new LED lights throughout the city (Wanseele, 2009). Each lamp is equipped with an advanced control system LightGrid, which allows city officials to regulate the degree of illumination and remotely using a dashboard to troubleshoot. San Diego can save about \$ 2.4 million from the current costs of lighting.

Diverse Factors

In order to modelling pedestrian movement behaviour and designing town planning, diverse factors need to be take into consideration. On the one hand, for human behaviour in evacuation or crowed events, the local density of population(indicating mobility need), Ethnic and cultural differences, and the per capita consuming capacity (indicating the prevalence of transportation apps or other technologies) should be taken into account. On the other hand, for land allocation in a specific city, land use accessibility, government budgets and environmental issues cannot be ignored. According to two aspects mentioned above, related data comparison presents in Table 2 between American cities and Australian cities, regarding different influencing factors in pedestrian traffic management.

As we can see from the table, the individual's income of people who lived in Adelaide is relatively lower than that of people who lived in other cities presented. But that does not impede that Adelaide is consistently ranked as one of the most liveable cities in the world. Actually, the city's success owes much to its plenty smart management strategies, including its advanced walking network and excellent pedestrian accessibility. For example, technologically, Smart LED Lighting and mobile applications are used widely, which provide safe walking routes for use whether at day or night. [20] Socially, it is ruled that giving priority to pedestrians on city streets, such as removing interruptions and obstructions along footpaths. Environmentally, its plain landscape makes it more possible to widen streets enough for easily accessing by people of all ages and levels of mobility.

In conclusion, to address the questions of designing a sustainable, walkable, liveable street forms, we need to consider not only the benefits of individuals and governmental profits, but also the diversity of city patterns economically, socially and environmentally. Pursing this further, I will mathematically build a

crosswalk model or a pedestrian traffic simulation system for a specific city and try to make it generally be concordant with the definition of smart city, in the remaining portion of the semester

3. RESEARCH METHODOLOGY

Conduct a daily review of information sources and conduct summary of each available research paper. Write the research findings.

The core sources to conduct this research report are

digital sources, books, white papers, articles, journals, websites, and databases: IEEE and Science Direct. This essential information was gathered as an establishment for the required investigation.

3.1 QUALITATIVE RESEARCH

To form a comprehensive view and to expand the understanding of the pedestrian monitoring and traffic systems and how it can be improved, the qualitative research method is used. This method includes steps such as the data collection and analysis and then the interpretation of it, by monitoring the existing works.

3.2 DATA COLLECTION

This research paper covers interviews, articles and books to collect and analyse information. This chapter covers summaries of all publications. the literature review discussed the existing pedestrian monitoring systems and already implemented systems in big cities around the World, the brief explanation of systems, which factors influencing pedestrian volume and traffic and also comparison in diversities between American cities and Australian cities is included in this research report.

Within the concept of the Internet of Things, one of the most popular areas of development is the concept of "Smart City". the fundamental principle of the "smart city" is the introduction of information technology and IoT facilities in the urban environment. It is expected that this approach will improve the management and interaction of the state with society, improve the quality and efficiency of urban services, and all together will change the life of the population qualitatively.

The research report covers existing monitoring systems to count pedestrians such as manual counting, video counting, infrared sensors, radioBeam and so on. There are many other counting technologies but they are more suited on cars and bicycles.

To get a better understanding on how to create a pedestrian footpaths, there is a need to consider indicators that influence travel patterns, in this research

report I considered socio-economic factors, trip related factors and infrastructural factors.

Moreover, there many existing pedestrian projects in big cities around the world. 1st May 2018, Wollongong introduces the project to count the pedestrians in real time. London implemented the project that allow to draw pedestrian pathways to minimise traffic. Dubai introduced Smart pedestrian signals.

This research report also considered diverse factors in order to modelling movement behaviour. By reviewing existing literature, it became possible to create a comparison analysis between American and Australian cities through human and environmental and economic factors. the analysis covers factors such as population, ethical differences, and land use accessibility.

This report was aimed at a deeper understanding of the concept of Smart City and how technologies are used specifically for pedestrians. By getting a comprehensive view about Smart city, it will be possible to modelling the approach to design more effective footpaths and street forms. Twenty five publications were analysed to address research questions and get a full picture of Smart city for pedestrians.

Despite the fact that IoT has been around for a long time on global market, but there is still no fundamental framework that would allow for cities to better understand the full potential of new technologies It is incredibly difficult to create a unique approach for each city on how to create footpaths and streets and more effective for everyone, each city has its own architecture, goals and life style.

Through the new technologies the government is able to manage large crowd which waiting was waiting at the street corner by automatically change the traffic signal to give pedestrians a chance to cross the road. There are many other examples.

If you look at the current streets of German, Swiss, Scandinavian, even Polish cities, then it is possible to see a lot of various elements that provide convenience and safety for all participants in the movement. Such a concept is known as proactive street design as opposed to passive design. For the future considerations I will summarized the traffic patterns for example mode share, weekend and weekday ratio to understand seasonal, daily and even hourly patterns for pedestrians.

5. CONCLUSION

This chapter covers the main outcomes of the work done and proposes research questions that can be addressed in future researches.

The research findings were derived from twenty five individual publications and research papers and other supporting literature. By reviewing existing literature, there has been found that there is no a unique solution for pedestrians to avoid traffic and make their life safer on the roads of the big cities. the research goal was to analyse existing pedestrian monitoring systems and

learn more about the IT solutions that were implemented in Smart Cities around the world. Also, this research paper analysed diverse influence factors in designing footpaths and street forms, through comparing typical cities in America and Australia.

clarifies the comparison of factors in designing
footpath.

Based on an analysis of appropriate literature, the concept of Smart City demonstrates the enormous potential of opportunities. Global urbanization is accelerating. Cities face growing pressure from increasing urbanization and constant population growth. the concept of "smart city" was chosen by many countries as a strategy for sustainable urban development. An increasing number of governments around the world are building "smart cities" through a variety of advanced technologies. Advanced wireless networks and Internet of things (IoT) allow using the ubiquitous connection; cloud computing provides data exchange and integration.

Despite the fact that, Smart City concept is on the market not first year, there is no a unique an idea of smart city pedestrian traffic modelling. Existing researches, dissertations and theories of Smart City with focused to pedestrians are far from maturity stage. This field is still in infancy stage where there are many challenges and new technologies which need to be studied and clarified.

In the evening, young men and women sing folk songs and tell each other their sincere feelings. the boys asked their targeted girls for their glutinous rice. the girls hide gifts in their meals to express their love for boys.

In order to show the national customs, what should i pay attention to is portray the embroidery patterns on Miao costumes carefully in painting. So it is also very important to understand them totally. " Outside the circle of the picture, there are Arabic style patterns and leaves and flowers woven with gold and silver thread, and surrounded by birds similar to phoenix at

the edge of the miniature. the striking color with smooth and harmonious pattern are the most obvious characteristics of this painting, which is similar to the pattern on the Persian carpet of the same era..

CHAPTER IIITHE PROCESS OF CREATING *ENJOY* THE HOLIDAY TIME(ABOUT 2021)

1.1 Conception, Drafting and Line Description

When learning fine brushwork, the painter's line drawing technology is very important. I will briefly introduce some line drawing skills in order to explain the course of my creation. Some techniques of India miniature will be used in combination with the techniques of Chinese painting.

In the facial features, India miniature painters can reflect the charm, personality and expression of the characters when drawing the lines of their *eyes*. It is difficult to express it with mediocre lines. It is necessary for us to learn and master the use of subtly changing lines to express its structure, perspective changes and the inner activities of the characters.

The following is a detailed picture of India miniature painters. For the line drawing of people's *lips*, Indian painters pay special attention to the angle of their structure, the drawing method of oral suture, the virtual and real relationship between the upper lip and the lower lip.

When painting the *nose*, India miniature painters noticed the characteristics of race. So for us, we should also pay attention to the differences in race, gender and age. In this way, when painting, you should usually pay attention to the different angles of the nose and the changes of its angle of view, especially the angle of the bridge of the nose.

It is not difficult to find that the *ear* is an easily overlooked part of the five senses by observing the hardness of India miniature or Chinese Meticulous Figure Painting. the body structure of ears is relatively complex. Therefore, we painters should learn human body structure to draw accurate and changeable lines. The above is the painting skills I learned from the figure modeling of India miniature, and I transcribed it into words, combined with my perception of Chinese painting creation, and recorded it together.

1.2 The Fusion Of Some Techniques of Color In Chinese



The following are some of the color techniques I learned in India miniature and applied to Chinese meticulous figure painting.

The colors used in India miniature are all natural mineral colors, which conform to the oriental philosophy of "nature". the natural mineral color has high stability and strong texture. It is also similar to mineral pigments and plant pigments in Chinese paintings. [3]

When I was creating, I often choose the tone relationship of weak contrast, because I prefer medium lightness. In my painting *Enjoy the Holiday Time* (about 2021), I made many attempts, such as cheerful high lightness colors, calm low lightness colors, and fresh cold colors.

The steps I learned from Indian miniature are: paint the color on the back of cooked Xuan paper, the color on the back must correspond to the color on the front.

Because of this technique, the use of color will be more obvious.

Personally, I think this is a change and improvement of the way of thinking and viewing angle, as well as a benefit and accumulation for future creation. Summarize this chapter with an ancient Chinese saying: "Only the quantitative change can achieve qualitative change."

[10] In addition, there are yoga teaching videos and apps such as "Wake Yoga" available on each network platform. Practitioners can practice yoga by following the APP. The second is softness. It is mainly reflected in three aspects. One is soft movement. Early yogis believed that all intense physical and mental activities would consume the potential of the soul, while gentle and gentle movements would help restrain the spiritual activities and reduce the consumption of the potential of the soul, so as to achieve internal and external empathy and "sameness of Brahma and I" [6]. Modern yoga is still dominated by soft and gentle static movements such as slant, half moon and side

crane pose. The second is soft breathing. To practice yoga asanas, you need to breathe deep and clear air, slowly exhale the turbid air, and breathe soft and deep in the abdomen. the rhythm, transformation and extension of all postures should be in harmony with the breath, which is fine and even, so that the mind and body become one and enter a state of calm and peace. The third is soft music. Yoga music is characterized by soothing, soft and natural. This is because soothing, soft and natural music can make people calm, relaxed and peaceful, which is conducive to yogis to relax their body and mind, eliminate interference and eliminate distractions, so as to clarify their mind and nature, and achieve the "sameness of Brahma and self" [6]. The third is soothing. This is mainly reflected in two aspects. One is to relieve the body. Yoga is static aerobics. All kinds of external asanas are for the purpose of stretching the body, and after all kinds of asana practice, it should be accompanied by meditation and rest exercises, so that all organs, tissues and joints of the body can be relaxed and relaxed from inside to outside on the basis of fully relaxing the muscles. the second is to relieve the soul. Yoga is one of the dharma practiced by ancient Indian monks. Ancient Indian monks practiced yoga to isolate greed, anger and delusion, and gradually relieve and purify their souls in order to become gods and sanctimonies. Modern yogis also practice yoga to relieve mental stress, maintain a calm and calm state of mind, and soothe the soul.

2.3 Function

As a cultural treasure of India, yoga has a long history, full of wisdom of India's sages. Modern yoga has penetrated into every stratum of society and played many functions. In summary, there are four main functions of yoga. One is to strengthen the body and cure the disease. This is mainly reflected in three aspects. One is to plastic muscles. Yoga poses are peaceful and soothing, and the muscles are often used for long periods of static isotonic movement. [11] This static isotonic exercise can enhance muscle strength, increase muscle volume, and have the effect of shaping and beautifying the body. the second is to regulate hormones. Regular practice of yoga asanas can improve endocrine and regulate the release of hormones. For example, practice plow pose, fish pose, shoulder stand and other yoga poses, can effectively improve the glands, so that their normal secretion of hormones, maintain the homeostasis. the third is to prevent disease. Yoga is aerobic exercise. Regular yoga can not only release adenosine triphosphate and other substances that dilate blood vessels, so that blood vessels maintain elasticity and prevent hardening of blood vessels; [12] It can also enhance the nutritional supply of cardiomyocytes and prevent cardiovascular and cerebrovascular diseases. Can also improve endocrine, improve immunity, prevent disease. The second is to regulate pressure and calm the mind to support health. This is mainly reflected in two aspects. One is to relieve mental pressure. In the practice of yoga rest and meditation, deep breathing and relaxed mental state, can relieve mental pressure, improve the nervous system control of the body, so that people calm down, maintain a peaceful state of mind. [13] Yoga's function of regulating mental stress and resolving negative emotions is conducive to health. Two is to create peace of mind. Yoga contains the idea of self-control, selfregulation. This kind of thought can regulate personal emotions in life, create a peaceful state of mind, achieve self-restraint and self-relief, develop an open-minded and indifferent attitude, which is beneficial to health. Third, spread culture and rejuvenate economy. This is mainly reflected in two aspects. One is to spread yoga culture. Yoga is one of the six philosophical factions of India and is a treasure of Indian culture. Modern yoga, based on the new Vedanta philosophical theory, has absorbed Western philosophical thoughts and become a fitness sport widely spread around the world, the healthy life concept advocated by Yoga Yoga has been accepted globally and even become an important basis for India's "yoga diplomacy". Second, contribute economic strength. With the improvement of people's living standard, people's appeal to health is getting stronger and stronger. In this situation, the yoga industry rose rapidly. In 2014, the market size of yoga industry was 6.17 billion yuan; In 2018, the market size of yoga industry was 32.21 billion yuan; In 2020, although some small and medium-sized offline yoga studios had to withdraw from the market due to the impact of the epidemic, their yoga industry market scale also reached 38.7 billion yuan. [14] So, Yoga industry market has created certain economic benefits for our country, and is a beneficial supplement to our country's economic prosperity. The fourth is to assist in cultivating people and shaping personality. This is mainly reflected in the following two aspects. First, to improve physical and mental health. Because yoga has a unique spirit and body integration of exercise characteristics, so practicing yoga can adjust the psychological state, regulate negative emotions, healthy individual body, cultivate a sunny body and mind. the second is to build a healthy personality. Edify yoga philosophy, practice yoga asanas, meditation, etc., can help people establish "self" awareness, reshape the inner world, self-management, self-liberation, form a correct world outlook, outlook on life and values, and self-discipline open-minded healthy personality. In addition, long-term practice of yoga, but also in the continuous improvement of yoga postures, beyond the self, develop never give up, difficult to exert the will quality.

3. THE STATUS QUO AND DILEMMA OF YOGA ENABLING GREAT HEALTH INDUSTRY IN EASTERN HUBEI

With the deepening of the concept of big health, the big health industry has entered a new era. In this situation, yoga, with its unique sports characteristics, has become one of the important methods for people to engage in health. Today, yoga industry as a sunrise industry in the big health industry, in the current traditional culture hot, not only has a huge audience, but also has broad prospects for development. However, its realistic development, there are also some difficulties.

3.1 Status Quo

The development of yoga industry in eastern Hubei started late and is still in the primary stage. At present, the big ACADEMIC PUBLISHING HOUSE

health industry market has not issued management regulations for the emerging yoga industry.

The status quo of yoga enabling great health industry in eastern Hubei is mainly reflected in three aspects. the first is that market chaos regulations have yet to be defined. the development of yoga in eastern Hubei is still in the exploratory period. At present, the local yoga industry has not formulated special laws and regulations, so that the eastern Hubei yoga industry market, more chaotic. It is mainly manifested in two aspects. One is operating without a license. Most of the yoga industry in eastern Hubei exists in the form of offline small and mediumsized yoga studios, while many small yoga studios are operating without licenses, and the related yoga industry is not regulated. Many coaches in small institutions have not obtained the yoga instructor qualification certificate, and their technical level has not reached the standard for teaching. Second, vicious competition. In order to compete for customers, many small and medium-sized yoga studios cut prices, attracting students at prices far lower than the market price, but after attracting students, it is difficult to maintain the follow-up business, resulting in closure. At present, the yoga industry in eastern Hubei has not established clear market operation norms, nor has it introduced precise programmatic documents and management rules, to prevent the vicious competition between the yoga industry. Second, the public is not informed of the single way of publicity. the existing publicity methods of yoga institutions in eastern Hubei are mostly offline propaganda by sending by acquaintances, recommendation advertisements and so on. the publicity methods are single. There are two reasons for this phenomenon. One is the single object of propaganda. People in eastern Hubei have a one-sided image of yoga that is exclusive to women. In yoga publicity, yoga institutions only target at women, resulting in a single group of yoga and poor publicity effect. Second, online propaganda is single. Most of the online publicity methods are for yoga institutions to publicize on wechat moments, which is not only single, but also small in scope. Nowadays, people receive information mostly from online platforms such as Weibo, Kuaishou and Douyin, and pay less attention to offline information acquisition channels, the publicity of yoga industry should also keep pace with the upgrading of information media, and extend the publicity of yoga industry to all online platforms, so that the publicity of yoga will develop in a diversified and rich way. The third is the lack of talent and the level of coaches is not high. Yoga industry has begun to take shape in eastern Hubei, but there is still a gap in the talent market of yoga industry. According to the survey, there are 98 yoga institutions in eastern Hubei, most of which have 6-15 yoga instructors. According to the average of 10 instructors in each institution, there are about 980 instructors in eastern Hubei. According to the 5000:1 training standard [15], there are 9, 339, 253 people in eastern Hubei, and 1, 867 yoga instructors are needed. But the existing yoga instructors, only 52.4%. Thus, the eastern Hubei yoga industry market, talent gap is huge. There are three main reasons. One is

the scarcity of local talent production. Local yoga talents in eastern Hubei mainly come from college students and outside business training. But the number of yoga students trained by colleges and universities every year is small, and the number of students who continue to engage in the yoga industry after graduation is even rarer, the scarcity of local yoga professionals is one of the main reasons for the shortage of talents in eastern Hubei. Second, it is not attractive enough to outside talents. the reasons for the lack of talent attraction in eastern Hubei are mainly shown in two aspects. First, the yoga atmosphere in eastern Hubei is not strong. People in eastern Hubei do not know much about yoga, and the demand for yoga is not high. Second, the economic situation of eastern Hubei is not good. In local yoga institutions, the salaries of yoga instructors are not high enough to attract non-local yoga talents. Third, there is no professional training institution. At present, there is no unified and standardized training institution for yoga instructors in eastern Hubei. Most of the existing yoga instructors come from commercial training within the yoga industry. This assembly line training produces yoga instructors, not only their own skill level is not high, but also lack of teaching experience. the coaches trained by assembly line cannot meet the market's demand for high-level core talents due to their lack of ability. However, there are few high-level yoga instructors with profound professional knowledge, rich teaching experience and special training.

3.2 Dilemma

Nowadays, the development of yoga industry in eastern Hubei is not smooth. Because, the big health industry in eastern Hubei, just started, still facing many difficulties. Yoga industry, as an important component of the eastern health industry, is no exception.

There are three main difficulties in the health industry in eastern Hubei province. First, it is trapped in the low level of local economy. In 2021, the GDP of eastern Hubei is 56.898 billion yuan, and the expenditure on health industry is 2.512 billion yuan, only accounting for 0.44% of the GDP. Compared with developed countries such as the United States and Japan, the GDP of the United States and Japan in 2021 is \$23 trillion and \$4.94 trillion respectively, among which the expenditure of the health industry accounts for 16.9% and 10.9% of the total GDP respectively. It can be seen that the developed degree of local economy has a great impact on the gross product of the health industry. In the past five years, the economic development level of eastern Hubei has been on the rise, from 430.715 billion yuan in 2017 to 556.898 billion yuan in 2021. But in 2021, the GDP of eastern Hubei only accounts for 0.48% of the national total. This shows that the economic development level of eastern Hubei is not high, the economic development level of eastern Hubei restricts the development of great health of eastern Hubei endowed by yoga. Because, only with the increase of people's income, people will improve the level of healthy consumption, and the yoga industry will get better development. Second, trapped in yoga exercise atmosphere is not strong. There are two main reasons why the yoga atmosphere in eastern Hubei is not strong. One is

that yoga has a single audience. Most people in eastern Hubei have a stereotype of yoga exclusive to women, which is related to the unscientific and one-sided propaganda of yoga. In the past yoga publicity, often stand in the female perspective, with the current female body anxiety, as a publicity stunt. On the market, most yoga studios take "slimming down" and "body shaping" as the slogan of publicity, labeling yoga as only for women, and making the functional and partial publicity of yoga, so that the public lacks a comprehensive and scientific understanding of yoga. Therefore, the audience of eastern Hubei yoga, mostly young women. the unitary audience of yoga in eastern Hubei leads to yoga activities being carried out in a small social group, with weak influence and weak atmosphere. Second, yoga activities are less. Yoga activities are an important way to expand the popularity of yoga and increase the audience. But in eastern Hubei, most yoga activities are initiated by small yoga studios to facilitate enrollment. It's a small yoga activity with little impact. Moreover, due to the lack of high-level talents in small yoga studios, yoga performance activities are at a low level, less attractive to the public and less social attention. As a result, the yoga movement atmosphere in eastern Hubei is not strong, and the audience cannot be expanded, which hinders the development of great health industry in eastern Hubei endowed by yoga. Third, it is trapped in the shortage of high-level yoga talents. High-level talents are the primary condition for yoga to enable the development of great health industry in eastern Hubei. There are three main reasons for the lack of high-level talents in yoga institutions in eastern Hubei. A market for the rapid coach rampant. the existing yoga instructors in the eastern Hubei market are mostly from within the industry and have been trained through short-term commercial training. They are not of high professional level and lack of teaching experience, so they cannot export excellent courses. [16] the second reason is that universities do not offer yoga as a major. At present, local colleges and universities in eastern Hubei have not set up major courses related to yoga industry. Most local colleges and universities in eastern Hubei set up yoga classes in the form of optional courses to do some basic yoga teaching. In addition, the teaching time is less, which seriously affects the training and transportation of yoga professionals and restricts the development of great health industry in eastern Hubei. Third, high-level brain drain. There are few yoga institutions in eastern Hubei, and due to economic reasons, a large number of scarce high-level yoga talents flow to first-tier cities and large yoga institutions in other places, resulting in the scarcity of high-level yoga talents in eastern Hubei, increasing the labor cost of yoga industry, the lack of development potential, difficult to open up a broader market, restricting the healthy development of the great health industry of eastern Hubei endowed by yoga. 4. STRATEGIES FOR YOGA TO ENABLE THE GREAT HEALTH INDUSTRY IN EASTERN HUBEI The development of yoga can bring new development opportunities and give new strength to the eastern Hubei Province, which lacks the "cure and cure disease" big health industry. the following three strategies can be adopted for yoga to enable the great health industry in eastern Hubei.

4.1 Create a healthy atmosphere for yoga in eastern Hubei In order to create a healthy atmosphere of yoga in eastern Hubei, it is necessary to improve the sense of existence of yoga in people's hearts, deepen people's understanding of yoga, change people's stereotype of yoga, and improve the popularity of yoga.

There are three main measures to create a healthy atmosphere for yoga. One is to create a good environment for yoga exercise. the creation of a good yoga environment is inseparable from the support of the government. the environment for yoga exercise requires elegance and quiet. the government of eastern Hubei can create an environment for yoga exercise with the help of the beautiful natural scenery of eastern Hubei. There are two main approaches. One is to create a yoga park. Yoga park can provide a good place for yoga exercise, which can attract more people who need to improve their health level and become yoga practitioners. the creation of yoga park can better connect yoga with People's Daily life, and create a good healthy atmosphere. For example, various yoga facilities such as ball yoga experience hall, aerial yoga experience hall and yoga meditation classroom can be built on the basis of the original park in the center of Yiai Lake. In part of the park, a yoga-themed park will be built to integrate the quiet and beautiful environment of the lake with yoga practice. Second, the construction of yoga cultural village. Yoga culture can be the main purpose of the construction of yoga culture village, can attract more tourists to eastern Hubei, drive the development of local tourism economy. It can also build a yoga business community integrated village and create a variety of yoga cultural experience pavilion. For example, we can build yoga culture museum, yoga facilities store, and cooperate with travel agencies to form cultural and tourism economic industry chain. Second, hold a variety of yoga activities. Holding a variety of yoga activities is a good way to publicize yoga, spread yoga culture and improve the influence of yoga. There are four specific methods. One is to hold art performances. Through yoga art performances, the public can understand yoga culture, feel the charm of yoga, create an atmosphere for yoga movement, and foreshadow the popularity of yoga. Second, organize parent-child games. Yoga parent-child games can enhance parent-child relationship at the same time, understand and learn yoga. Parents and children can complete the corresponding asana movements together, in the process of asana practice, understand yoga, enhance parent-child relationship. Three is to carry out knowledge questions. Yoga quiz will help people understand the benefits of yoga practice and stimulate their interest in yoga. During the event, you can also give yoga themed souvenirs for challengers of yoga trivia. Four is to hold the asana challenge. Yoga asana challenge, try to get as many people as possible to participate in this challenge and experience the fun of yoga. You can choose a variety of yoga asanas of different difficulty, so that the challengers can complete from easy to difficult. Finally, the winner is

the one with the highest number and difficulty. Or choose a balance yoga pose of low and medium difficulty. the challenger can maintain balance for a long time. Third, do a variety of yoga publicity. There are two ways to do this. One is synchronous online and offline publicity. the large flow of new media can be used to publicize online and offline classes simultaneously, which can expand the scope of yoga publicity and attract more people to understand and learn yoga, so that one person teaches offline and many people enjoy online classes. For example, excellent yoga works can be photographed and uploaded to the online platform; In addition, online yoga postures can be explained and online meditation rooms can be set up to realize online multi-person yoga classes, the second is to enrich the propaganda content of yoga. Enriching the propaganda content of yoga can expand the audience of yoga and meet the different needs of different people for yoga. Targeted publicity should be carried out for different yoga courses to improve the public's understanding of various yoga courses. For example, parent-child yoga classes, promoting parent-child relationship; Meditation rest technique, to adjust the pressure of life to form a healthy state of mind; Pregnant women yoga classes, to regulate pregnancy anxiety, exercise pregnant mothers body, maintain healthy pregnancy publicity; Fitness yoga course, to strengthen the body, fitness, exercise body strength, balance ability propaganda.

4.2 Build a yoga enabling great health system in eastern Hubei

To build a yoga enabling health system in eastern Hubei, and lay a foundation for the healthy development of yoga industry market. In view of the present situation of no clear rules and regulations, no supervision mechanism, and mixed talent market in the yoga industry in eastern Hubei, the following three specific measures are proposed to build the yoga enabling great health system in eastern Hubei.

First, the establishment of yoga market management regulations. With the rise of yoga industry, the market competition among yoga institutions is gradually fierce. At present, the unstandardized market regulations hinder the development of yoga industry. There are three ways to set up regulations for the management of yoga market. One is to establish rules. the establishment of market norms for voga industry can protect the rights and interests of yoga institutions, serve as evidence for adjudication of market competition disputes, make internal management of yoga market orderly, improve management efficiency, and encourage better development of yoga industry. For example, we can set up healthy market competition norms for the chaotic yoga competition market, the punishment mechanism can be set up for the behavior of market bidding up, malicious suppression and vicious market competition. [17] the second is to grasp the audit. Strengthening the audit of yoga market is helpful for yoga enterprises to fulfill various economic responsibilities and ensure the healthy operation of yoga market. For example, the economic operation of yoga enterprises can be targeted at the establishment of a review body to prevent tax evasion. Yoga teaching effect audit regulations can be set up according to the low-quality teaching and training level of yoga. Three is to check the qualification. Checking the qualification of yoga instructors in yoga institutions can ensure the quality of yoga talents and screen out unqualified yoga instructors. In view of the chaotic employment mechanism of yoga institutions, the qualification verification mechanism of yoga instructors can be established. We can regularly assess the skill level of the instructors in each yoga studio. [18] the second is to establish a yoga market supervision organization. the establishment of good management mechanism cannot be separated from the maintenance of regulatory institutions. There are two ways to establish the supervision organization of yoga industry market. One is hierarchical check. A multi-level supervision and hierarchical census system can be established for yoga institutions to ensure that every yoga institution can be regularly reviewed. For example, a general supervision organization can be set up in eastern Hubei, and then a municipal branch can be set up in Huanggang, Huangshi and Ezhou. From the city to the district and the district to the county, regular supervision can be conducted on each yoga institution every year or half a year to ensure the management of lower supervision institutions by higher supervision institutions. Two is the definite content. the supervision content of the yoga industry supervision body should correspond to the content of the management regulations one by one, so as to determine the supervision body to examine the market competition, teaching quality and institution qualification of yoga institutions. [19] For example, healthy market competition should be advocated to ensure the quality of yoga industry and supervise the healthy operation of yoga market. Third, raise the threshold for yoga instructors to enter the market. At present, most of the yoga instructors in the eastern Hubei market come from short-term commercial training within the industry, but have not received systematic professional yoga training. There are generally problems such as low professional level and insufficient teaching ability. There are three ways to raise the threshold for yoga instructors to enter the market. One is to check the qualification. Check the teaching qualifications of instructors in yoga institutions. Many accelerated yoga instructors have teaching certificates that are issued and certified by informal organizations. the government can set up a special yoga teacher training institution for the issuance of yoga instructor certification. Just as the "National Yoga Alliance" in the United States sets up different types and levels of yoga teacher certification, categories such as children's yoga certification and pregnant women's yoga certification can be set up. An official website of yoga certification can be established to ensure that the information of every teacher who has obtained a formal yoga teacher certification can be found in the official website. To ensure that every coach with a teaching qualification certificate has qualified professional level and relevant teaching skills. Second, regular assessment. the skill level of yoga instructors should be improved continuously in the process of continuous learning and teaching. Regular assessment of the skill level of yoga

instructors can ensure the quality of yoga industry output. It is stipulated that yoga instructors' skill level should be audited every six months or a year. Yoga teachers in different districts can gather together to conduct level audit. In the level audit, yoga teaching experience can be shared and teaching techniques can be exchanged. Review content, according to the yoga skill level of the instructor, yoga asana skills of different difficulties can be displayed. In addition, the teaching design of different yoga contents can be carried out according to the teaching ability of the instructors, so as to comprehensively assess the abilities of the instructors. Three is a clear level, the uneven market talent of yoga industry restricts the healthy development of yoga industry. Yoga instructors who enter the market should receive vocational training in formal professional institutions of the government, and obtain teaching certificates of different levels according to the degree of training. For example, 200 hours certified instructor, 300 hours certified instructor, children's yoga certified instructor, etc. And every year or half a year, accept different difficulties of asana skills and teaching ability assessment, so as to ensure the professional level of yoga industry market talents, so that the yoga industry a virtuous cycle of development.

4.3 Training yoga to enable great health talents in eastern Hubei

Talent is the foundation of the healthy development of the industry. the development of great health industry in eastern Hubei is inseparable from talents.

There are three main measures to train yoga to enable great health talents in eastern Hubei. First, attach importance to the construction of college yoga courses. At present, yoga classes in colleges and universities in eastern Hubei exist in the form of elective courses, and students learn yoga classes in short time and less content. To solve this problem, the construction of yoga courses in local colleges and universities in eastern Hubei can be started from three aspects. One is to add content to yoga classes. Due to reasons such as course length and students' interest, yoga courses taught by yoga teachers in colleges and universities in eastern Hubei are few and simple. the existing teaching content is mainly the basic yoga asanas. For example, right Angle pose, squat, deadbolt pose, snake pose, horse pose, etc., and composed of them such as "Sun worship 12 pose", etc., simple yoga asana combination. the yoga movement, did not make in-depth systematic study. the content and difficulty of yoga courses should be increased appropriately to help students acquire more profound yoga knowledge and skills. For example, you can learn more difficult yoga poses such as King pigeon pose, side crane pose, wheel pose, bird of Paradise pose and so on. You can also learn more types of yoga, such as hot yoga, altitude yoga, etc. Two is to increase the yoga class hours. Yoga classes in universities in eastern Hubei are optional, with only 32 credit hours. With fewer class hours, what teachers can teach is limited, and it is difficult for students to learn more yoga knowledge and skills in a short time. Schools should increase the length of yoga classes according to different majors. For example, for students majoring in physical education, the duration of yoga courses can be increased to at least 48 hours, and for those who choose to major in yoga, the duration can be increased to 144 hours. Only in this way can they comprehensively and systematically master all poses of yoga, as well as different ways of meditation and relaxation. the third is to set up yoga major course. On the basis of the general yoga course, which mainly focuses on the basic yoga asanas, the major course of yoga is set up, so that students can have the opportunity to systematically and deeply learn the theoretical knowledge of yoga, master all the yoga asanas, and reach the level of being able to independently create multiple sets of yoga asanas and practice yoga concepts, so as to improve the reserve of professional talents in the yoga industry market. Second, establish a training base for yoga talents. the cultivation of yoga talents should not only rely on the study of yoga courses in colleges and universities, but should set up scientific, reasonable and systematic training bases. There are two specific methods. One is to clarify the function of yoga training base. For those who want to obtain the yoga instructor qualification certificate, they can be assessed to master the quantity, quality and teaching level of yoga asanas. Then, according to the assessment results, four corresponding levels of primary, intermediate, advanced and special grade are established, and the corresponding level of yoga instructor qualification certificate is issued. For those who are already yoga instructors, they can be assessed every six months or a year, mainly for the level of yoga asanas and yoga teaching. If you do not pass the examination, you will be downgraded based on the original qualification. Second, to build a high-quality teaching team. the members of the high-quality teaching team shall be composed of yoga instructors with special professional certificates and high-level yoga athletes. They also serve as the training teachers of the training base and the annual professional qualification examiners, in order to cultivate senior yoga talents who can contribute to the great health industry in eastern Hubei. [20] Third, unimpeded channels for yoga talents. There are two main ways to establish a yoga talent transfer network from the training base to the market. First, to strengthen cooperation between schools and enterprises. A written cooperation agreement can be signed between colleges and universities in eastern Hubei and major yoga institutions to establish a long-term cooperation mechanism on the basis of defining the responsibilities and rights of both parties, so that colleges and universities can become talent training bases for yoga institutions. In the process of talent training, senior yoga instructors can be hired to serve as vocational guidance counselors in colleges and universities in eastern Hubei. Practice points can also be set up in yoga institutions to help college graduates in eastern Hubei get familiar with yoga market environment and learn yoga teaching techniques. Second, establish a communication platform. Build a communication platform between yoga talents and market institutions to ensure the benign circulation of yoga talents. For example, yoga recruitment APP can be established online to publicize the scale, number of yoga institutions, salary level, basic information of yoga

instructors, qualification certificates, awards, etc., basic information for the two-way choice between yoga instructors and institutions. We can also hold job fairs offline for all yoga instructors and yoga institutions, and have one-on-one interviews with instructors. To build a network of talents, markets and institutions, and promote the development of great health industry in eastern Hubei endowed by yoga.

5. CONCLUSION

With the promulgation of "Healthy China" policy and the improvement of national health literacy, the big health industry has ushered in a new development opportunity. However, the current development of the big health industry in eastern Hubei still has some problems, such as market chaos and regulations not yet determined, little public knowledge and single way of publicity, lack of talents and low level of instructors, low level of local economy, low atmosphere of yoga, and lack of high-level talents of yoga. In order to solve this problem, the author puts forward the strategies of creating the atmosphere of yoga enabling great health in eastern Hubei, constructing the system of yoga enabling great health in eastern Hubei and cultivating the talents of yoga enabling great health in eastern Hubei. This not only has positive significance for promoting the popularity of yoga in eastern Hubei, but also has practical guiding significance for driving yoga to enable the development of great health industry in eastern Hubei. It needs to be explained that, due to their profound understanding of yoga culture is not deep, understanding is not clear, in the face of extensive and profound yoga culture, analysis of its evolution, characteristics and functions, shallow theory, weak, innovation of its ability to enable the great health industry in the east of Hubei, the heart is weak, in the future research, when in-depth analysis.

Development Dilemma and Rescue Path of Yoga in Colleges and Universities in Eastern Hubei Under the Background of Great Health

Abstract: This paper uses the method of literature, field investigation and expert interview, with" great health" as the purpose, in order to clarify the development of yoga in the common colleges and universities of eastern Hubei as a breakthrough, the development of yoga in the common colleges and universities of eastern Hubei rescue path, made a study. the results show that: since yoga is an elective course in colleges and universities in eastern Hubei, students' understanding of yoga is increasing year by year, and their interest in yoga is gradually improving. More and more students choose to learn yoga. However, under the background of general health, the development of yoga in colleges and universities in eastern Hubei is still faced with many problems, such as insufficient cognition of exercise concept, incorrect cognition of yoga movement, low professional level of yoga teachers, dull teaching methods, lack of teaching equipment and venues, single propaganda methods and other disadvantages. In view of these disadvantages, in order to develop yoga in colleges and universities in eastern Hubei, the paper advances with the Times the ways of establishing the concept of great health, correctly recognizing yoga, following the requirements of great health, improving the quality of yoga teachers, responding to the call of great health and attaching importance to the construction of yoga courses. This not only has a guiding effect on the construction of yoga courses in general colleges and universities of eastern Hubei under the background of great health, but also has a positive significance for promoting the development of yoga in general colleges and universities of eastern Hubei. 1. INTRODUCTION

Nowadays, with the development of economy, people' s living standards are constantly improved, and their demands for health are increasingly high. on October 25, 2016, the (C-P-C) Central Committee and the State Council issued the Outline of "Healthy China 2030" [1], and required all regions and departments to conscientiously implement it in light of the actual conditions. In June 2019, the State Council issued the Opinions on Implementing the Healthy China Action [2],

which improved the coordination mechanism for promoting the Healthy China Initiative to ensure its effective implementation. These powerful policies provide powerful policy support for the construction of yoga courses and the spread of yoga in colleges and universities. Under the background of implementing the strategy of "Healthy China" [3], what is the development status of yoga, which is very popular among students, in colleges and universities? What are the difficulties? and so on, aroused the wide concern of teachers and students in colleges and universities. Based on this, it is of practical significance to explore the feasible development strategy of yoga in the general colleges and universities of eastern Hubei in combination with the actual situation of the general colleges and universities of eastern Hubei and closely related to the general health background of "healthy China" strategy.

It focuses on people' s clothing, food, housing, transportation, birth, aging, illness and death, pays attention to factors affecting health, advocates self-health management, and pursues complete health of spirit, psychology, physiology, society, environment and morality. "Great health" is a new concept that enables people to "live a good life, live a long time, do not get sick, get sick less, get sick late, improve the quality of life and walk safely" [5]. It is necessary to create a good national fitness atmosphere and encourage people to actively participate in fitness sports. Third, not only cure the disease, but also cure the disease. "Great health" requires a healthy and upward lifestyle, not only to "cure diseases", but also to "cure diseases" [6], eradicate the "sub-health" state, fundamentally improve people' s physical fitness, help people change the old way of overspending health and fighting diseases, and form a new mode of health care and disease prevention. Traditionally, yoga is a practice for the inner soul. After thousands of years of evolution, modern yoga has become a means of fitness for people. the advance of yoga is closely related to the transfer of society. In different historical periods, yoga will undergo different evolution. There are three main evolution rules of yoga. One is the transmutation from few records to system records. In the primitive development period, yoga was presented only in the form of sitting and meditating, with few written records. It was not until the 15th century BC that the word "yoga" first appeared in the Brahmanic religious classic Veda [8], and the systematic record of yoga began. In the centuries that followed, other Upanishads expanded the concept of "yoga" and further interpreted the use of techniques such as meditation, mind control and proper breathing to achieve a state of transcendence. the Bhagavad Gita, for example, focuses on the practice of several branches of Yoga and their importance to life. Then, over time, as yoga evolved, its various branches were systematically documented. the second is from the professional monk door to the mass transmutation. the original yoga, which is a special dharma practice, was realized by ancient Indian practitioners after observing animal behavior in the primitive forests of the Himalayan foothills in India. Confined to the region, it was spread only in the eastern part of the Himalayas and in the virgin forests, by yogis, to those who were willing to practice. and then it spread to the average Indian. After the 19th century, yoga developed rapidly in India, and more and more yoga works and branches of various practices appeared. Through the promotion of Indian capitalism, yoga gradually spread to the world. Today, yoga has been widely practiced around the world, the third is the evolution of both the mind and the body. the original yogis practiced for the purpose of purifying the mind, achieving the integration of self and nature, obtaining eternal peace, sublimating the mind and realizing the "unity of nature and man". For this reason, most of them focus on practicing their spiritual nature, hoping to achieve "sameness between the Brahma and the self" from the inside out. Up to modern times, yoga has been widely spread in the world, and people tend to practice yoga, and cultivate the body and mind, and obtain a comprehensive health of spirit and flesh.

4 CHARACTERISTICS AND VALUE OF YOGA

4.1 Features

Everything in the world has a special distinction from another thing, that is, characteristics. Yoga is no exception, but also has its unique characteristics from other traditional health and fitness techniques.

Yoga is different from other traditional health and fitness techniques, there are three main characteristics. First, we have a deep understanding of the ontology of life the ontology of life derives from the fundamental relationship between the living individual and the universe as a whole -- each individual being a part of the whole, and at the same time encompassing all the whole. Life itself is constantly changing. What will happen in the future? It' s impossible to predict. Yoga' s understanding of the essence of life is to teach people to

listen to the voice of life, giving people the peace of mind to accept changes and not worry about the future. Second, culture is intersectional and inheritable. Yoga is not only a culture of physical movement, but also a culture of philosophy. the intersection of these two cultures makes yoga not only positive in terms of physical and mental health, but also positive in spirit. It is because of these two positive influences that yoga has been widely recognized and become a historical and cultural treasure, passed down from generation to generation. Third, it has a wide range of health benefits. There are two main aspects in this regard. One is suitable for all ages. Yoga emphasizes moderation and conformity to nature. Regardless of the student' s foundation, age and gender, he or she can choose his or her own training content according to his or her own situation. Do what you can and when you can. the two are both physical and mental. Yoga is a way to achieve harmony and unity between the body and the mind. It has the function of nourishing both body and mind. [9]

4.2 Value

Value depends on people' s subjective intention to things. the same thing, to different people, the size of the value may be very different. A world treasure such as yoga, which has been around for more than 5, 000 years, is of great value to individuals and to human society as a whole. There are four main values of yoga. First, historical value. There are two more. One is that the history of yoga is an important part of Indian history. Yoga originated in India and has been around for thousands of years. A history of yoga not only reflects the history of India, but also is a useful supplement and an important part of the official history of India. Second, yoga is an important embodiment of the history of Indian religious culture. Yoga is a jewel of Indian classical civilization, with its philosophical roots in the Vedas. the Veda, a collection of ancient Indian knowledge, is the foundation of Indian philosophy, religion and literature. Therefore, the history of religious culture infiltrated by yoga reflects, from one aspect, the history of Indian religious culture. Second, cultural value. There are two more. One is that yoga has a diverse culture. Yoga culture not only embodies the ancient Indian civilization in the Indus Valley, but also inherits the ancient Egyptian civilization in the Nile Valley. Up to now, yoga culture has formed a multi-structured modern yoga culture that integrates philosophy, aesthetics and unique ideas of physical and mental health. Secondly, yoga is a treasure of world culture. Yoga continues to this day because of its complete science, high artistry and unique wisdom. Since the 20th century, it has been proved to be one of the most suitable and effective self-cultivation methods for human beings through in-depth studies in both East and West. [10] Third, the value of educating people. There are two more. One is to cultivate the quality of will. At the beginning of yoga, it is inevitable that you will suffer from the pain of pulling muscles and ligaments. Bottlenecks in practice can also lead to feelings of frustration and frustration. After the introduction, you will feel softer, more powerful, and get a sense of accomplishment and satisfaction. In the process of

practicing yoga, pain can sharpen one' s will, frustration can exercise one' s tolerance, a sense of achievement can cultivate one' s self-confidence and other qualities of perseverance and perseverance. Second, cultivate correct values. Yoga is philosophy. the practice of yoga, whether it is simple postures, breathing, asanas, or high level meditation, requires the practitioner to have the support of Vipassana in order to improve himself, to achieve "Brahma identity", to generate the perception of giving back to society, and to mold the correct values. Fourth, health value. There are two more. One is to keep fit. When practicing yoga, "standing, lying, sitting, kneeling and other asana exercises combining static and static activity" [11], combined with fine and even breathing, gentle posture adjustment, fully bending, stretching and twisting all parts and joints, stimulating all meridians and acupoints, can promote the flow of qi and blood, massage all organs, regulate the internal environment, enhance human immunity and self-healing power, and improve health. the second is to nourish the heart. Yoga emphasizes peace and stability and the pursuit of physical and mental harmony. Often practice yoga, can adjust the nerves, release the mind, dispel negative emotions and external adverse factors produced by the side effects, cultivate a calm and objective state of mind and a kind and confident attitude to life, is beneficial to nourishing the heart.

5. DEVELOPMENT STATUS AND DILEMMA OF YOGA IN COLLEGES AND UNIVERSITIES IN EASTERN HUBEI

5.1 Development status

At present, Chinese colleges and universities, almost all incorporate yoga into the college curriculum. In order to enrich college life and carry out the concept of "health first" and "comprehensive health", universities in eastern Hubei also include yoga in their physical education courses. But in practice, there are still the following phenomena.

First, the faculty is not strong. There are two more. One is the shortage of teachers. In the colleges and universities of eastern Hubei, there are few yoga teachers because of the lack of educational investment and the lack of yoga courses. According to national standards, to ensure the quality of teaching in colleges and universities, there should be one yoga teacher for every 15 college students. However, the teachers of ordinary colleges and universities in eastern Hubei are all lower than this standard, so that the yoga teachers of ordinary colleges and universities in eastern Hubei are also insufficient. For example, Huanggang Normal University has only three yoga teachers, while Hubei Normal University and Hubei Institute of Technology have only one yoga teacher each. Second, poor professional ability. Since yoga did not begin to rise worldwide until the 21st century, there are fewer teachers majoring in yoga in universities, and the theoretical and technical system of yoga teaching in universities is still in the exploratory stage, leading to the lack of professional ability of yoga teachers in universities. Moreover, due to the rapid development of yoga in China in recent years, the level of yoga teachers in different

universities is uneven, and many yoga teachers even major in sports dance, aerobics, etc., rather than yoga when they study in college or graduate school. This is because they went to school at a time when yoga was not popular and yoga teachers were scarce. For example, the yoga teachers in Hubei Normal University study modern majors, not yoga majors. Second, the site equipment is insufficient. There are two more. One is the lack of space. According to the national standard, there should be one gymnasium for every 10, 000 to 20, 000 students. In the gymnasium, there should be at least one yoga studio that can accommodate about 30 students or a comprehensive hall that integrates aerobics and sports dance. Because of the different regional development degree, the teaching equipment and site of the colleges and universities in different regions are different. For example, Huanggang Normal University and Hubei Institute of Science and Technology have complete yoga teaching facilities and fixed yoga venues for classes, while the yoga venue of Hubei Normal University is integrated with the gym. Second, insufficient equipment. Due to the imbalance of regional development and other factors, yoga equipment is insufficient in colleges and universities in eastern Hubei. For example, students need to purchase yoga MATS and elastic belts for yoga classes in Huanggang Normal University and Hubei Normal University by themselves. the school does not provide corresponding yoga equipment, and teachers also need to prepare the acoustics required for yoga classes. In addition to yoga venues, the school does not provide any equipment required for teaching. Third, the gender imbalance. There is a great difference in the proportion of male and female students attending yoga courses in the general colleges and universities of eastern Hubei. Almost all students are male and female. According to the survey, from 2020 to 2022, the number of students taking yoga classes in ordinary colleges and universities in eastern Hubei will be between 60 and 80 each semester, and they will offer two hours of yoga classes every week, with about 20 to 30 students in each class. There is a large gap in the proportion of male and female students attending yoga classes in colleges and universities in eastern Hubei. From 2020 to 2022, the ratio of male and female students attending yoga classes is 1:5, 1:3 and 1:3 in Huanggang Normal University, 1:10, 1:12 and 1:10 in Hubei Normal University, and 1:8, 1:8 and 1:8 in Hubei Institute of Technology. It can be seen that the number of female students attending yoga classes in colleges and universities in eastern Hubei is far higher than that of male students.

5.2 Development Dilemma

5.2.1 Cognitive dilemma

Cognition is an information processing activity for individuals to know the objective world. [12] Correct cognition can improve work efficiency, especially the cognition of ideas. Misperception, or lack of it, can lead to very different results.

There are two main cognitive yoga dilemmas for students in colleges and universities in eastern Hubei. One is the lack of understanding of yoga concept of physical and mental health. There are two more. One is the lack of awareness of yoga mind raising concept. College students only think that yoga can be beautiful posture, strengthen the body, ignore the effect of yoga to regulate mood, relieve mood, calm mind and nourish the body. Meditation and meditation are an important part of yoga practice. Through meditation and meditation, college students can relax their mind. [13] in the process of meditation, emotions can be adjusted, bad emotions can be removed, impetuous and impulsive inner calm can be calmed, and the reality can be faced with optimism. the second is the lack of cognition of yoga fitness concept. Owing to the lack of comprehensive understanding of yoga, the students of ordinary universities in eastern Hubei study passively, mechanically and with vague motivation. Many college students think that learning yoga can lose weight process, so they have to participate in order to get a better body. Affected by this, they can hardly understand the connotation of yoga, which affects the learning effect. Some students think yoga is gymnastics, which weakens the value of yoga and hinders the learning of yoga. Second, the cognition of yoga movement is wrong. There are three more. One is the wrong understanding of yoga learning object. Most male university students in eastern Hubei think that yoga is only suitable for girls to practice, do not learn yoga. In European and American countries, the proportion of men practicing yoga is much higher than that of women. Secondly, the cognition of yoga practice form is wrong. There are many ordinary college students in eastern Hubei believe that yoga is suitable for people with soft body to practice, lack of yoga practice, will make the body more soft. Third, the function of yoga is wrong. Some students in ordinary colleges and universities in eastern Hubei think that yoga is a course to lose weight, so they learn yoga with the purpose of slimming down fat, but the result is counterproductive. This misconception leads to their later disinterest in yoga.

5.2.2 Teaching dilemma

Teaching is the first priority of all schools. It can be said that the teaching quality is directly related to the reputation of a school. Affected by various factors, yoga teaching in colleges and universities in eastern Hubei also faces some difficulties. There are three.

First, the professional level of yoga teachers is not high. A good yoga teacher is the premise of teaching good yoga courses. At present, the professional level of yoga teachers in colleges and universities in eastern Hubei is not high. It is embodied in the following two aspects. One is that the major does not match. Yoga teachers in colleges and universities in eastern Hubei are mainly teachers majoring in calisthenics and Latin dance, and their professional knowledge and skills are not systematic, which is not conducive to the achievement of yoga teaching objectives. For example, the yoga teachers in Hubei Normal University are concurrently teachers majoring in modern studies; One of the yoga teachers at Huanggang Normal College is a part-time teacher who majored in basketball. Second, the teaching content is simple. Yoga teaching in the general colleges and universities of eastern Hubei, professional "Yoga" elective courses, open 32 class hours; "College sports - Yoga" option class, also open 32 credit hours. Because of the time, yoga teaching content is simple. For example, the Yoga class of Huanggang Normal University only teaches the basic twelve forms of worship. Hubei University of Science and Technology "college sports - Yoga" class, only by the basic students to teach relatively simple yoga movements, students do not know other yoga content. Second, the teaching mode is boring and tasteless. There are two more. One is the tradition of teaching concept. Due to the influence of traditional teaching concepts, the current yoga teaching in colleges and universities in eastern Hubei is still a phenomenon of teachers' active indoctrination and students' passive acceptance. Teaching is lack of enlightenment and inquiry, and learning is lack of initiative and interest. [14] Yoga teachers prescribe routine movements and students blindly imitate training, failing to help students grasp the essence of yoga. It is difficult for students to obtain pleasant physical and mental experience through practicing yoga in daily learning. Second, the teaching method is single. Yoga is a sport that moves to music. However, yoga teachers in ordinary colleges and universities in eastern Hubei have a single teaching method and only use simple demonstration teaching methods, which is difficult to stimulate students' enthusiasm for learning yoga, guide students to think independently and improve their enthusiasm for learning yoga. [15] Third, the lack of teaching facilities. the smooth development of yoga teaching activities cannot be separated from sufficient sites and equipment and other hardware conditions. [16] However, general colleges and universities in eastern Hubei do not pay enough attention to yoga classes, and invest less construction funds and insufficient equipment. the yoga belt, yoga block, yoga mat and fitness ball required by the course should be purchased and prepared by students themselves. Students without equipment will have no equipment to use, and there are few professional yoga studios and their matching yoga teaching equipment. For example, Huanggang Normal University, Hubei Normal University and Hubei Institute of Technology three ordinary universities, all have a dedicated or dualpurpose yoga studio, but none of them have yoga equipment, before class, the teacher requires students to prepare the yoga equipment used in this semester.

5.2.3 Publicity dilemma

Propaganda is a kind of information performance technique to serve a specific issue. As far as education is concerned, publicity is an important part of education, and so is yoga teaching. However, restricted by funds, resources and other factors, colleges and universities in eastern Hubei also face some difficulties when propagating yoga, which are mainly reflected in the following two aspects.

First, the propaganda method is single. the way to publicize yoga in colleges and universities in eastern Hubei is mainly oral propaganda and document release. For students who are keen on and immersed in mobile phone gossip, word of mouth, for them, just like in one ear and out the other, does not play much role. the publicity documents released on some public platforms, due to the

text content, students who are used to fast food culture, and it is difficult to calm down and read carefully, so that they know very little. Second, the professional publicity is poor. In the face of yoga, a sport with profound cultural heritage, it is far from enough to stick to oral and document propaganda without intuitive and in-depth interpretation. Because, compared with pictures, videos and other intuitive publicity methods, for laymen, too much propaganda text description, it is difficult to make them interested in yoga, so that many students do not know that the school has yoga classes, or do not know what the yoga class to learn, and stay away.

6. RESCUE PATH OF YOGA DEVELOPMENT IN COLLEGES AND UNIVERSITIES IN EASTERN HUBEI UNDER THE BACKGROUND OF HEALTH

Under the circumstance that the living standard is basically well-off in an all-round way, the "great health" concept of "living well, living long, not getting sick, getting less sick" [5] has become the main melody of the development of national life. In this situation, although the development of yoga in colleges and universities in eastern Hubei ushered in a rare opportunity, but also faced with some cognitive, teaching and publicity difficulties. To this end, the following three rescue paths are proposed. 6.1 Establish the concept of big health and correctly understand yoga

Since the concept of "big health" was put forward, yoga, as a physical and mental exercise, has been favored by the public. However, people only know yoga, but fail to recognize and interpret yoga with the concept of "big health".

There are two main measures to establish the concept of big health and correctly understand yoga. One is to create a yoga atmosphere on campus. There are two more. One is to increase publicity. Colleges and universities in eastern Hubei should strengthen the propaganda of yoga. For example, the university radio station, campus official website and wall newspaper can be used to interpret the origin, development, value and function of yoga, so as to stimulate students' desire to learn yoga. Second, enrich activities. Colleges and universities in eastern Hubei should organize and carry out rich and colorful yoga activities. For example, it can organize and carry out various yoga performances, observation or competitions on campus, and also organize and carry out yoga academic exchanges, expert interviews, teaching observation, asana performance and other activities on campus to create a yoga atmosphere. the second is to correct the wrong perception of yoga. There are two more. One is to correct the wrong perception of suitable for women and unsuitable for men. Yoga themed activity days, wechat official accounts and classroom teaching can be held to tell the relevant theoretical knowledge of yoga and show yoga asanas, so as to change students' wrong perception that "yoga is suitable for women, not for men". the second is to correct the wrong cognition of weight loss and fitness. Through conducting yoga lectures, setting up yoga knowledge columns, and using Douyin self-media platform, we can answer the questions and perplexity of ordinary college students in eastern Hubei on yoga and their wrong cognition of losing weight and not keeping fit. 6.2 Follow the requirements of Great health and improve the literacy of yoga teachers

Human being is the subject of all activities, and human accomplishment is the fundamental factor that affects and restricts work efficiency. As the leader of teaching activities, the quality of teachers is the basic condition to ensure the quality of education, but also the necessary condition to cultivate good students. [17]

There are three main measures to follow the requirements of big health and improve the quality of yoga teachers. First, strengthen the introduction of yoga teachers. Increasing the introduction of yoga teachers is one of the effective ways for the rapid development of yoga in colleges and universities in eastern Hubei. There are two more. One is to attract multiple channels to supplement educational talents. Through the open recruitment plan to recruit teachers, for those who are willing to participate in the recruitment, after unified written examination, interview and assessment procedures, excellent yoga teachers will be recruited to the teachers of ordinary colleges and universities in eastern Hubei. the second is to care for and retain educational talents in many ways. Concerned about the vital interests of yoga teachers, from the aspects of food, clothing, housing and transportation, constantly improve the economic benefits of yoga teachers, implement the benefits that yoga teachers should enjoy, and set up awards such as excellent yoga teachers, excellent yoga teachers team, to encourage the individual and collective yoga teachers to be calm and willing to teach. the second is to improve the moral quality of yoga teachers. [18] Yoga teachers should be trained before they are introduced. There are two specific methods. One is pre-service education. Before entry, general colleges and universities in eastern Hubei should test the professional ability of the yoga teachers who will be admitted. It is not only necessary to test their ability to explain knowledge, but also to test their professional ethics such as caring for students, loving their jobs and being a teacher, and explain the rules and regulations of the school, so that the teachers can be prepared to be teachers from the aspects of psychology, knowledge, skills and so on. the second is post-job training. After admission, the general colleges and universities of eastern Hubei should regularly examine the moral quality and teaching ability of yoga teachers, and temper their quality of love and dedication; An incentive mechanism should be established to spur the advanced and encourage the backward, so that yoga teachers can move forward in the spirit of perseverance. the third is to cultivate yoga teachers' professional ability. One is to grade yoga teachers. Colleges and universities in eastern Hubei should make use of the evaluation standard of yoga level to build a team of highquality yoga teachers. the assessment of yoga teachers should start from the three aspects of theoretical literacy, technical ability and teaching level, and evaluate the grades of primary, intermediate and senior yoga teachers. Through grading, yoga teachers are encouraged to make progress. the second is to do a good job of mentoring.

Colleges and universities in eastern Hubei should make group management according to the basic situation of yoga teachers, and set up leaders in each group, so that teachers with high teaching level and rich teaching experience can guide young teachers and work together to cultivate a high quality yoga teacher team.

6.3 Respond to the call of great health and attach importance to the construction of yoga courses

As an important part of the healthy development of students, the construction of college physical education curriculum has been concerned by schools. the construction of yoga courses in Hubei colleges and universities is no exception, especially under the background of "great health".

To respond to the call of great health and attach importance to the construction of yoga courses, there are three measures. First, improve yoga teaching facilities. There are two more. One is to increase investment. In the construction of yoga courses in colleges and universities in eastern Hubei, we should first understand all kinds of equipment, venues and number of classes required for opening yoga courses, and then according to the actual financial resources of the school, we should purchase yoga teaching equipment and facilities to improve the teaching environment of yoga courses. the second is scientific configuration. the teaching and practice of yoga have high requirements on the environment. Only under the premise of scientific allocation of yoga teaching facilities, teaching activities can be carried out efficiently. For example, Huanggang Normal University only has a yoga studio without sound equipment and yoga MATS, and yoga teachers need to provide music for yoga rest techniques. Schools should be equipped with yoga MATS and sound equipment according to teaching needs. Second, the construction of yoga school-based curriculum. There are three more. One is continuous modification and gradual improvement. the construction of yoga school-based curriculum in colleges and universities in eastern Hubei is not accomplished overnight, but a continuous, dynamic and gradual improvement process. Yoga teachers should revise the school-based curriculum suitable for the school according to the social demands, local cultural characteristics and students' actual knowledge. Two is careful control, reduce the difference. the construction of school-based yoga curriculum in colleges and universities in eastern Hubei will inevitably assign the power of curriculum preparation to yoga teachers, which will inevitably lead to the differences of yoga teaching content and teaching quality between schools. In order to reduce this difference, the general colleges and universities in eastern Hubei should carefully compare the yoga teaching requirements issued by the Ministry of Education, and develop a suitable yoga school-based curriculum. Three is to plan carefully, determine the candidate. the development of school-based yoga courses in colleges and universities in eastern Hubei usually requires the participation of many people and involves a large range. Among them, some yoga teachers may lack the specialized theories and skills to develop school-based yoga courses. Therefore, yoga teachers with stable career and solid knowledge of school-based curriculum development should be selected to develop school-based curriculum.

Third, establish a yoga publicity platform. There are two more. One is to establish a yoga community. Colleges and universities in eastern Hubei should encourage students who are interested in yoga, establish yoga associations, regularly carry out propaganda courses on basic yoga knowledge and basic asanas, and regularly carry out yoga activities such as performance, communication and observation. For example, you can ask a professional yoga teacher to guide you, try yoga solo, double poses, etc. the second is to expand the propaganda channel. Most of the existing yoga publicity platforms in colleges and universities in eastern Hubei only display award-winning photos of yoga in campus columns and allow students to publicize themselves. In order to better promote the publicity of yoga in colleges and universities in eastern Hubei, we should take the forms of holding yoga lectures, organizing yoga competitions and organizing inter-school yoga exchanges to broaden the publicity channels and mobilize the enthusiasm of students to learn yoga. Promote the construction and development of yoga course from the side. [19]

7. CONCLUSION

With the promotion of "Healthy China 2030" strategy, yoga, as a moderate intensity, self-cultivation exercise, has gradually entered people' s vision, and also gradually entered the common colleges and universities in eastern Hubei. Especially since yoga is an elective course in colleges and universities in eastern Hubei, students' understanding of yoga is increasing year by year, and their interest in yoga is gradually improving. More and more students choose to learn yoga. However, under the background of general health, the development of yoga in colleges and universities in eastern Hubei is still faced with many problems, such as insufficient cognition of exercise concept, incorrect cognition of yoga movement, low professional level of yoga teachers, dull teaching methods, lack of teaching equipment and venues, single propaganda methods and other disadvantages. In view of these disadvantages, in order to develop yoga in colleges and universities in eastern Hubei, the paper advances with the Times the ways of establishing the concept of great health, correctly recognizing yoga, following the requirements of great health, improving the quality of yoga teachers, responding to the call of great health and attaching importance to the construction of yoga courses. This not only has a guiding effect on the construction of yoga courses in general colleges and universities of eastern Hubei under the background of great health, but also has a positive significance for promoting the development of yoga in general colleges and universities of eastern Hubei.
